The competent authority in the Ministry of Water Resources, River Development & Ganga Rejuvenation has approved the constitution of a Committee on Ganga Act, as per the following constitution of the Committee:

The Committee may co-opt any other member, if required.

2. The Terms of Reference of the Committee would be as under:

- (i) Preparation of Draft Act on Ganga ensuring wholesomeness of River Ganga;
- (ii) The Act should cover cleanliness (Nirmalta) and Uninterrupted e-flow (Aviralta) and corresponding provisions thereof;
- (iii) Any other issue which the Committee may deem fit in the drafting of the Act.

3. The tenure of the Committee would be for a period of three months which may be extended by another three months, if required.

3. The TA/DA of non-official members for attending the meetings of the Committee will be met by NMCG as per extant rules. In addition, sitting fee @ Rs. 3000/- per day shall also be paid to non-official members for the meetings of the Committee. However, for the quantum of sitting fee to be paid to non-official members of the Committee, the Department of Expenditure, Ministry of Finance is in the process of framing general guidelines/norms which will be conveyed in due course.

4. This issues with the approval of competent authority in the Ministry and concurrence of Integrated Finance Division dated 21.7.2016.
